### Not quite business as usual.

Our renewal process begins next month with some new changes license holders and non-practicing members should be aware of.

This month, over 5,000 people will begin the activities necessary to continue licensure and membership with PEGNL.

While this busy time of year is bolstered by an efficient process, renewals for 2020 have some marked differences from previous years.

PEGNL has introduced a fee increase for the upcoming year. The new fees and the rationale for the increase are outlined on page 2.

Recently, we've been reviewing the Life and Non-Practicing Member categories and that process was finalized this month. On page 3 we provide an overview of the amendments that were made. Our new member portal, which was described in the last issue of *illuminate*, will provide an easier renewal process. This is further detailed in the article below.

Before you prepare to renew, please take a moment to learn about these changes, along with other PEGNL news.

## Annual Renewal

In early November, Members and Permit-to-Practice Holders will receive a notice regarding their annual renewal.

This year, in an effort to move towards paperless operations and to streamline the renewal process for our members, we will be emailing our renewal letters to all those with a valid email address. **Only those without a valid email address will receive a paper copy of their letter and invoice.**

Those receiving the renewal by email will find instructions on how to login to our new member portal, along with how to retrieve your invoice, renew your license, permit or unlicensed membership online, submit professional development reports and change personal information. Those receiving a paper letter will be asked to update their email address, as an email address is required, in order to use the member portal.

We encourage you to check out the portal by accessing our website ([www.pegnl.ca](http://www.pegnl.ca)) and clicking "Log-In" at the top of the page. **All those who access the new member portal system from now until December 1 will be entered into a draw for a \$100 gift certificate to the restaurant of their choice.**

# PEGNL Fee Increase


License holders renewing for 2020 will see an increase of about 10% in their professional fees.

Section 8.(1) of the Engineers and Geoscientists Act states: “In prescribing the fees payable under this Act, the board shall, so far as it is practicable, ensure that the amount of fees is sufficient to enable the association to exercise its powers under this Act.”

PEGNL licensing fees were last increased 13 years ago (in 2006). Since that time, inflation, as measured by the Consumer Price Index (CPI), has increased 28%.

Just over 40% of PEGNL’s professional license holders reside outside the province. Most become licensed in NL so that they may work on projects here. As major projects wind down, some individuals and companies will opt not to renew their licenses which will negatively impact the organization’s revenues.

Prior to this increase, the PEGNL fee for professional licensure was the lowest of any of the 15 regulators of engineering and/or geoscience in the country. Subsequent to the increase, only one regulator (Professional Engineers Ontario) has a lower fee for professional licensure.

# Final Changes to Member Categories

As you may be aware, PEGNL has been reviewing its non-practicing and Life Member categories.

This review arose in part due to challenges regarding whether unlicensed members could use the professional designations. Under the Engineers and Geoscientists Act, only “professional members” - defined as those who are *registered to engage in practice* - are permitted to use the professional designations (P. Eng. and P. Geo.)

The review of the Non-practicing & Life categories, and proposed changes during each phase of the process were communicated in an article in our [May edition of illuminate](#), in the Chair and CEO Report of our [June edition of illuminate](#), and in an [email sent directly to all members](#) on August 27. Correspondence was also sent to all those immediately affected by the proposed changes. (For more information, please click the links for each item above).

During this outreach period, we asked members for feedback which was recorded and considered throughout the Board’s decision-making process.

Upon the completion of this consultation process, the Board of Directors voted on the final changes to our member categories, as are stipulated in By-Law 1. The new version of this by-law, complete with amendments to all categories, can be found [here](#).

Below we outline some key changes made to each member category.

## Life Membership

Life Members using a professional designation are now required to add a qualifier of either (Retired) or (Non-Practicing) after its use. For example, someone who was formerly licensed as a P. Geo. in the province, and is now a Life Member, will use either P. Geo (Retired) or P. Geo. (Non-Practicing).

Use of either qualifier will clarify to the public that the member is not licensed to practice.

Life Members will now also need to submit an annual declaration that they will abide by the Code of Ethics and that they understand the conditions of membership.

Fees for current Life Members will continue to be voluntary. Applications for Life Membership, for those who are eligible, will no longer be accepted after December 31.

## Non Practicing Members

Going forward, there will only be one Non-Practicing category which will be for those unlicensed individuals wishing to maintain membership with PEGNL and who are not already Life Members. Anyone who has been licensed to practice either profession in Newfoundland and Labrador, but who is currently not practicing is eligible for membership as a Non-Practicing Member.

Similar to Life Members, Non-Practicing Members must use the (Retired) or (Non-Practicing) qualifier with their designation and also submit an annual declaration form.

Annual fees for Non-Practicing Members are 20% of the License Holder fee. See page 2 for information on this year’s fees.

Life and Non-Practicing Members will be sent a letter outlining the member agreement to be completed by December 31, along with instructions on applying for and eligibility to return to practicing status.
