The following items arise from our 2015 strategic plan and associated communications plan. These focus on PEGNL's reason for being; to regulate practitioners of engineering and geoscience in the public interest. Our strategic plans themes are: placing greater emphasis on competency, both ethical and technical; improving our communications with groups with which we link; furthering our efforts of recent years on compliance with the Act, especially ensuring practitioners are appropriately licensed; and good stewardship of resources, through upgrading our internal infrastructure and better utilizing the important contributions of volunteers.

The April 8, 2016 Board of Directors Meeting was held at the PEGNL Office in St. John's. Preparations for the Annual General Meeting (AGM) and Board elections were a significant part of this meeting with the Board reviewing and endorsing the slate of candidates put forward by the Nominations Committee. The Board's auditors presented its positive report on the 2015 annual financial statements with the full 2015 annual report now being available. The Board reviewed and approved the nominated list of Award winners arising from the work of the Awards Committee and the Environment Committee. The award winners will be presented at our Awards dinner during the evening of our AGM and conference.

Among other matters reviewed during the meeting was PEGNL's relationship with the Architects Licensing Board of Newfoundland and Labrador (ALBNL). Discussions are ongoing with ALBNL and Service NL, the government department that administers both the Engineers and Geoscientists Act as well as the Architects Act, regarding the extent of overlapping practice. We continue to work towards an acknowledgment of the area of overlap, that best serves the public. In addition, PEGNL is reviewing its options for its office accommodations. The lease for the current location expires in October. The Board continues to work on its strategic planning processes, evaluating future trends that may impact the practices of engineering and geoscience and especially the regulation of the professions.

PEGNL's disciplinary processes are an important part of administering the Engineers and Geoscientists Act in the public interest. Those licensed by PEGNL, both as individuals and as companies, are required to practice in accordance with ethical and technical standards. When members of the public or other practitioners feel circumstances warrant, they may contact PEGNL and make an allegation against a licensed individual or a licensed company.

Currently PEGNL's Professional Standards Director is investigating two preliminary matters which may or may not lead to formal allegations and further steps in the discipline process. Over the past month three allegations have been resolved through registrar resolution with two allegations remaining in the registrar resolution stage. Two allegations are currently with the Complaints Authorization Committee (CAC). For one of these, an outside investigator has been appointed by the CAC to conduct an assessment of the allegation. The second is in the early stages of the CAC review. There are no matters currently subject to a disciplinary hearing. Through an RFP process, OPEN Communications was selected to help PEGNL facilitate a branding project. The project included the input from various groups such as volunteers, license holders, stakeholders, staff, and members of the public, as well as an environmental scan of brands and communications strategies employed by other similar organizations in and outside of the province.

The project concluded with a new brand being produced for PEGNL. Among the new elements of the brand are:

- a brand narrative
- a new logo
- new colours
- a new tagline
- our electronic newsletter Dialogue was re-branded (now known as Illuminate)
- a new website, including new microsites for National Engineering and Geoscience Month, and Environmental Engagement (formerly Green Spot)

New branding was also applied to the PEGNL Chapters. The Chapters (East, West, Central, and Labrador) are now referred to as Connections, each with its own logo and distinct colours. We have also started developing microsites for each of the Connections, beginning with ConnectionsEast and will complete the others later this year.

For some time we have seen the need to update our website. The existing one has not been substantially changed since it was first introduced with the then new branding in 2004 that we are replacing today. For example, our previous website did not adapt its presentation to whether a person was using a desktop, a tablet or a smart phone, the new one does. It provides a PEGNL face to the world that enables us to meet the information needs of the various stakeholder groups that will be using the website. The new website is now up and running (www.pegnl.ca).

Our new Illuminate newsletter integrates more effectively with our new website, having a similar format and 'feel'.

Our new logo with tag line is not substantially different from our previous one, We felt that PEGNL is an acronym that is recognized by many, and that the stylized map of the province is an important statement about who we are. The new colours add a more modern context to the logo. We have added a tagline to the logo, "Professional Excellence, Public Trust". We feel that it captures in a few words what PEGNL and those that it licenses are all about. We strive both for professional excellence and for public trust. It is these two elements that are the foundation of our code of ethics.

You will have noticed that we have initiated a survey of those we license. Hopefully you have responded to the online survey. It will help us meet your needs better within the context of our primary role of regulating practitioners of

> engineering and geoscience in the public interest. Your views about both how we serve you and how we serve the needs of the public are important to us in planning for the future.

The new brand has been launched through this edition of Illuminate and will be officially introduced at PEGNL's Conference & AGM on June 17.

The changes to the brand arise from a need to communicate more effectively with license holders, stakeholders, and the public in a more effective and modern way.

elections to fill three vacant positions on PEGNL's Board of Directors are ongoing. Members with email addresses have been sent access codes that enable them to vote electronically. The Board is PEGNL's governing body and it is important to have good representatives undertaking that role in administering the Engineers and Geoscientists Act and working in the public interest. Voting closes June 14.

The annual election of directors of Professional Engineers and Geoscientists of Newfoundland and Labrador is taking place in May - June 2016, with the results being announced at the PEGNL Annual General Meeting scheduled for June 17, 2016 at the Delta Hotel in St. John's.

There are 14 Directors: nine directors who are elected by PEGNL members, three public representatives appointed by the Minister of Government Services and two ex-officio non-voting members. Three of the elected directors are executive directors: chair elect, chair and past chair. Six of the elected directors are non executive directors. The two ex officio non-voting members of the Board are the Dean of MUN Engineering and the Head of the MUN Department of Earth Sciences.
